

Dissemination Conference Grants – Up to 2 Available!

The COST Action Justice360 hereby invites applications for Dissemination Conference Grants (DCG). Related to the project Justice360. To make sure presentations relate to the focus of Justice360, please consult the Memorandum of Understanding (MoU) found here: <https://justice-360.com/wp-content/uploads/2019/12/MoU-CA18228.pdf>. The conference or workshop in question does not have to be organized by the relevant COST Action.

Justice360 offers two DCG Grants for conferences that take place before the end of February 2024. Through a decentred approach of international criminal justice, the theoretical and methodological developments of JUSTICE360 will also be branded to disseminate to other research fields. Each DCG Conference Grant has a maximum award of up to **2000** euro. To be eligible for a Conference Grant, applications have to live up to the criteria below. Applications should be made by **December 7, 2023., and the Conference should take place before the end of February 2024.**

To be filled in e-COST:

- Title of the presentation
- Conference title, date (within the active Grant Period, i.e. no overlap across two consecutive Grant Periods) and venue;
- Budget requested;
- Attendance Type (face to face or virtual)

To be uploaded to e-COST:

- Application form (template available on e-COST) describing: Alignment with the Science Communication Plan25 adopted by the COST Action and Expected impact to the COST Action.
- Copy of the abstract of the accepted oral presentation focused on promoting the scientific achievements and activities being performed by the COST Action;
- Acceptance (or invitation) letter from the conference organizers;
- **Other documents required by the Action (e.g. recommendation letter, etc...)**

Dissemination Conference consists in an oral presentation by an Action Participant of the work of the Action in high level conferences fully organized by a third party, i.e. not organized nor co-organized by the COST Action.

Dissemination Conference:

- Significantly increase visibility of the Action in the research community, can contribute to increasing visibility of the presenter;
- Attract additional participants and stakeholders and disseminate Action results to relevant end-users at high profile conferences in the field on a topic relevant to the Action.

Grantee delivers the approved oral presentation, actively networks with other participants and promotes the COST Action to the potential stakeholders;

After the Conference, the Report should be written:

The required report/documentation for claiming a Dissemination Conference Grant are:

1. Report to the Action MC on the outcome of the presentation, contacts made and potential for future collaborations;
2. The certificate of attendance,
3. The programme of the conference or book of abstracts / proceedings indicating the oral presentation of the grantee
4. Copy of the given presentation

Award criteria:

- Contribution to the COST Justice360 aims and strategic priorities
- Topic of the oral presentation and the topic and the quality of the conference (number of participants, public outreach, networking opportunities etc.)
